**Terms and Conditions EBF Conference 2021** 



**Conference Student & Staff Participants** 



<u>Student & Staff Participant</u>: the natural or legal person with whom an agreement has been made with respect to participation in the EBF Conference 2021.

EBF Conference Board 2021: the organiser of the EBF Conference 2021.

## General:

1. These Terms and Conditions are part of all agreements concluded between the EBF Conference Board 2021, hereinafter referred to as 'organisation', and a participant to which these conditions apply, to the extent that the parties did not explicitly and by letter deviate from these terms and conditions.

# Article 1: Cancellation participant

- 1. The participant has the possibility to cancel the registration. Cancellation takes place by e-mail or by registered letter. The participant should send the cancellation to the address provided by the organisation. The cancellation has to be received before the 30th of September 2021. Delay in the transmission and receipt will be at the expense and risk of the participant.
- 2. For cancellations after the 30th of September 2021, the participant is obliged to pay the full invoice amount. The assessment of the cancellation period will be based on the date of the postmark or date of receiving the e-mail. In case the participant terminates the participation after the start of the conference, or does not participate in the conference at all, the participant is not entitled to any refund.
- 3. In case the participant registered for the dinner at the Martini church, and the place has been assigned to the participant, then the participant is mandatory to attend the diner. If the participant is not present, a fine of €30,- will be distributed.
- 4. The participant is able to unsubscribe for the dinner for free before the 30th of September 2021.
- 5. In case the participant registered for a recruitment lunch, and the place has been assigned to the participant, then the participant is mandatory to attend the recruitment lunch. If the participant is not present, a fine of €30,- will be distributed.
- 6. The participant is able to unsubscribe for the recruitment lunch for free before the 30th of September 2021.
- 7. In case the participant registered for a recruitment workshop, and the place has been assigned to the participant, then the participant is mandatory to attend the recruitment workshop. If the participant is not present, a fine of €30,- will be distributed. The participant is able to unsubscribe for the recruitment workshop for free before the 30th

## **Article 2: Cancellation organisation**

1. The organisation reserves the right to cancel the conference until 5 workings days before the start of the conference. Due to covid-19 the format can be subject to change. The participants will receive a message as soon as possible when this is the case. When cancelled, the participants will receive the full amount of money back.

#### **Article 3: Grouping program parts**

1. The participant can forward his or her preferences regarding which parts of the conference to attend. The organisation reserves the right to group the participants. It is possible that a participant is classed in another workshop or masterclass than the one of his/her preference.

#### Article 4: Program

1. The program is at any time without prejudice. The organisation is not responsible for deviations in the program and possible damage which thereby arises for business participants or other stakeholders.

### Article 5: Access

- 1. The organisation reserves the rights to deny participants at the entrance of the conference, when the organisation believes the participant to misbehave or dress inappropriately.
